Who we are

The Small Business Development Corporation (SBDC) is an independent statutory authority, established in 1984 under the Small Business Development Corporation Act 1983.

The primary role of the SBDC is to encourage, promote, facilitate and assist the establishment, growth and development of small business in Western Australia. This is achieved by providing practical advice, information, and guidance to small business owners.

The SBDC also offers a dispute resolution service, delivers skills development workshops for existing and aspiring small business operators and investigates unfair practices that impact small business. The Corporation provides advice and support to the Minister for Small Business on matters affecting the sector, advocates for policies that nurture the growth and diversity of the sector and raises awareness of the importance of small business to the economy.

With 97 per cent of businesses in Western Australia defined as small businesses, their success makes a big impact on the state's economy.

Our work to advocate for and represent the interests of small business is an essential part of ensuring Western Australians can start and grow their businesses in a fair operating environment, that gives them the opportunity to succeed and grow.

Our investigations and inquiry capacity will be used to collect evidence, take action and ultimately protect more businesses from the impacts of adverse behaviours towards them by other businesses or government entitities.

Exposing these activities including poor payment and contracting practice, will be a key focus of the Small Business Commissioner.




Where to find us
